- 2. Minutes. The minutes of the Reorganizational Meeting held January 18, 2022, were attached to the Agenda and were reviewed by all members in attendance prior to meeting. Tom Sochacki moved for approval of the minutes and waiving formal reading, second by Terry Painter; approved by 5-0 vote.
